

Leasing Permit Procedure and Application
Mossy Creek Property Owners Association

The Covenants for Mossy Creek require the owners to obtain a "leasing permit" from the Board of Directors prior to entering into a lease.

Per the Declaration of Covenants (Leasing Amendment) for Mossy Creek Property Owners Association , no more than 10% of the total number of units (4) will be eligible for rental permits.

This form solely pertains to obtaining approval from the HOA to rent your home through the fulfillment of the requirement to obtain a leasing permit. It does not contain all the provisions which apply to leasing a unit.

Individual owners are responsible for reading, understanding and complying with all sections of The Mossy Creek Covenants pertaining to home rental/leasing. Failure to comply with any of the requirements pertaining to rentals may result in fines and/or loss of approval for rental of the home.
